The new registration form had now been provided by the Monitoring Officer at Epping Forest District Council and should be completed and returned to the Town Council Office.
- c. there was a new legal requirement to publish the registers of interests on both the District and Town Council websites.
- d. under Section 33 of the 2011 Act a member or co-opted member of a parish council with a disclosable pecuniary interest may submit a written request to the proper officer at the parish council (the Town Clerk) for the parish council to grant a dispensation to relieve him/her of the restrictions in Section 31(4), namely to participate in a discussion or vote on a matter in which he/she had a disclosable pecuniary interest.
- e. a review of the Code and its arrangements would be undertaken after twelve months.
- f. the Town Council may leave the scheme at any time.
