Agenda item 7 Drainage Works

The Services Manager met with Trevor Baker, Principal Engineer, Environmental Protection & Drainage, Contracts & Technical Services, (EFDC on Tuesday 18 May 2021, to discuss the continuation of drainage works to the land adjacent to South Loughton Cricket Club. The work had commenced in November 2020, but due to a prolonged period of weather leading to ground saturation, coupled with unforeseen issues with the configuration of the existing land drainage on site, the work had been postponed over the winter/spring period. Trevor Baker outlined the following scope of works, which would see the project through to completion:

- 1. A small section of pipe will be laid beneath the opening in the hedge line to ensure the run-off of water stored in the ditch that runs from the base of the mound. This is currently a dead end, and at the time of the meeting the ditch was full of water.
- 2. To ensure the flow of stored water, a shallow ditch will be dug from the new pipe (see point 1 above) through to the small 'blocked' section of pipe close to the playground gate. The new ditch will run parallel with the rear fence line of the playground and is land that is not used by the public as it is a narrow space sandwiched between the playground fence and the hedge line.
- 3. The small section of blocked pipe (see point 2 above) will be unblocked thus allowing water to flow into the ditch that runs through to the river.
- 4. To summarise, the work will see the creation of a continuous ditch running from the base of the mound through to the ditch that feeds into the river, thus allowing for the run-off of flood water from the field that houses the playground.

These measures will afford a greater chance for flood water to drain out of this area of land. However it should be noted that in times of extreme wet weather its effectiveness will be dictated by factors such as the level of the River Roding and the degree of rainfall.

Subject: Roding Valley play area

Dear Paul

It was good to meet with you and Mark recently to discuss the future

improvements/refurbishment of the children's play area at Roding Valley.

We discussed relocating the play area to the flatter ground adjacent the tennis courts. The actual area will be dependent on the budget.

You told me you intended to use the existing fence, where possible.

It is recommended that an access footpath off the main path is constructed to the new gate. The path should be a minimum of 1.2 metres wide with a wider area at the gate, say 3m wide x 1.5m. This will allow for the opening of the gate and pushchairs to access without going onto the grass. There should be two pedestrian gates, 1.2 m wide, that open out into the playing field for a quick escape. If there is any grass within the fence line then a service gate will be required.

The recommended age group for the new site would be up to 12 years - to be confirmed - and should include swinging, sliding, climbing, rotating and rocking. Seats, litter bins and signs will also be required. An additional item for older children could be installed outside the fence with the main contract or at a later date. Approximate budget of £5-6K to include safer surfacing.

To give you an idea of what you can get for your money I have attached some schemes from HAGS from £50,000 to £100,000. This cost will include equipment, installation and safer surfacing. It is not clear if any fencing or hard landscaping has been included.

I would suggest that £75,000 is a good round figure that will include tarmac to any remaining areas around the safer surfacing.

There are a few sites that offer funding

This information is just a guideline to start with. Once you know what your budget is you can work on a specification of what you want to send out to the play companies.

I'm on the board for the 16th Scout troupe over in Debden. They've had lots of difficulty with the people they hire their room from over the years, and have been desperate to build/find their own scout hut. They also have lots of children with additional needs/disabilities, so the need for affordable and usable space is crucial. They do have a very long waiting list which would allow them to open up spaces for 3 times as many kids as they have now, but the building they currently hire won't allow them to rent more evenings. They also aren't able to meet in the building right now as they aren't supplying them with a COVID updated property risk assessment.

Needless to say, having their own scout hut on Debden Estate would be absolutely amazing. They have raised some money over the years for this, and just this week the Scout Association announced a pot of funding which will be available soon to help scout groups build their own hut. When this opens, groups will need to move really quickly though.

So, I'm hoping we could start a conversation about whether or not the town council could help us with finding some land to build on please? Either that, or possibly finding an existing building which could be re-purposed and turned into the 16th's Scout Hut?

Agenda item 17 Land adjacent to Willingale Road Allotment

Epping Forest Countrycare attended site on Thursday 6 May 2021 and carried out a volunteer work session. As with previous sessions at this site, grass was cut and areas covered in bramble were cut-back. A pathway has also been created, which runs through the section of brambles close to the border with Debden Park High School. Whilst on site, Countrycare Officers placed a number of refugia (mats to encourage habitat for reptiles and insects) around the site. On 24 May 2021 the Services Manager met on site with Damian Weller from Countrycare to discuss the recent works, and on inspection of the refugia it was noted that many were now home to slow worms, common lizards and a grass snake.
