## Agenda Item 7 Council Precept for 2025/26

## The Council is asked to consider:

- I. the budget for 2025/26.
- II. the movement in earmarked (funds) reserves for 2025/265; and
- III. the level of the precept for 2025/26.
- 7.1 At its meeting on 15 January 2025, the Resources and General Services Committee considered the Estimates submitted by all the Committees. It also looked at the Council's running costs predicted for Financial Year 2025/26 and the financial forecasts predicted for the Financial Year End of 2024/25.
- **7.2** The Responsible Financial Officer (pending) will elaborate on a few factors that have influenced the budget. Overall new Earmarked Funds of some £35,000 have been added to cater for various envisaged Town Council projects. The budget proposed in the agenda report was agreed by the Resources and General Services Committee on 15 January 2025. The revised Earmarked Funds summary is shown on Appendix 1 page 11.
- **7.3** Summary of the Committees' Estimates The Resources and General Services Committee RECOMMENDED to Council that the precept for 2025/26 be set at £1,061,038 with the budget details (recharges added in) as set out below.

## 7.4 Precept for 2025/26

For information the tax base for 2025/26 has been confirmed as 13,184.1\* (This is the figure that when divided into the Precept gives the Band D figure).

\*Note – Epping Forest District Council re-stated tax base – notification received 20.12.24

#### **RECOMMEND** that the Council's precept for 2025/26 be set at £1,061,038

This will set the Loughton proportion of the annual council tax for a band D property as  $\pounds 80.48$ , an increase of  $\pounds 4.13$  ( $\pounds 0.08$  weekly) from the current year of  $\pounds 76.35$ , a 6.75% increase.

The Resources and General Services Committee reiterated that the Council have worked intensively to keep this as low as possible, whist maintaining service standards and the capability to fulfil a few key future projects.
