15 Tree Survey

The comprehensive tree survey (some 111 pages) has now been reviewed. Owing to the size of the report, a separate electronic copy will be forwarded to Committee members along with the agenda. In summary ‘the majority of trees were found to have good vitality with no visible major defects’. Only one tree in the Willingale Allotments area needs imminent urgent work. However there are a number of trees that require attention within 90 days.

The amount of tree work required in the Town Council Cemetery and Lady Whitakers Mead exceeds existing budget.

Recommend :-

- Some of any additional costs be sourced from General Reserves
- Should there be a significant increase in General Reserves at financial years end 31/3/25, then allocate some earmarked reserves (EMR) as Tree EMR.
- Allocate some funding from the £10k Closed Churchyard if necessary.
- There will be additional sources of funding from the 2026/27 budget

- Specific budget allocations should be made for tree work in the 2027/28 budget in the three principal areas, relevant to this committee. i.e. the Town Council Cemetery, Willingale Allotments and Lady Whitakers Mead.

It is also recommended that the office works through the list in priority, obtaining relevant quotes and informing the Committee at future meetings, in respect of work carried out and impact on tree budget allocations .

Each of the category winners received a laminated certificate, along with an engraved cup (to keep for 11 months). The winners were all absolutely delighted with the recognition shown for their efforts. Runners-up and highly commended entrants received laminated certificates.

The judges commented on the winning entrants:

The winners chosen were Forest Casual & Schoolwear, in the local/independents, “*two members of the team, Katie and Claire had created a festive display cleverly incorporating the stores products*”; David Clulow, Opticians in the Multiples, who achieved “*a striking visual impact with their design*”; Haven House Children’s Hospice Shop, in the Charities “*for its abundance of Christmas cheer*”; and The Aviary for the Eateries, who had “*produced a most impressive illuminated display*”.

Willingale Road Allotments Report

Current Situation

All tenancy agreements have now been signed and all payments received. One plot remains vacant; it requires some work before it can be re-let, and there are currently eight people on the waiting list.

An inspection of the allotment site was carried out on Tuesday 25 November 2025. Following the inspection, the relevant tenants were contacted and asked to tidy their plots, remove any waste, and prepare for winter. These plot holders are being monitored and will be followed up where necessary.

Cesspit

The cesspit is continuing to be monitored.

Request for anti-climb paint

We would like to apply anti-climb paint to the tops of the allotment gates to help deter intruders from climbing over. Appropriate warning signs would be installed, and the painted areas would be positioned at least two metres above ground level, ensuring they do not affect passers-by, fully complying with all relevant rules and regulations.

Request for the covering of water troughs at Willingale Road Allotment

Ensuring safe and hygienic water storage is essential for allotment sites. Uncovered troughs pose risks to health, safety, and regulatory compliance. Guidance from multiple sources emphasise the need for water containers to remain covered when not in use.

The Local Government Association warns that uncovered water butts can endanger both children and wildlife, recommending the use of secure covers. Practical experience also shows that uncovered barrels deteriorate quickly, developing algae, attracting mosquitoes, and collecting debris, making lids vital for maintaining water quality.

Training materials from the Essex Association of Local Council's allotment course reinforce this, noting that covered water storage reduces contamination and supports water conservation.

I also consulted Ray How, a representative of the National Allotment Society, whose extensive experience makes his advice particularly valuable. He strongly endorsed covering water troughs and demonstrated how this is successfully implemented at his Southend allotment site, confirming the practicality of adopting the same approach at our site.

In summary, covering water troughs is good practice and an important measure for safety, hygiene, and compliance. It protects children and wildlife, prevents contamination and mosquito issues, meet regulatory expectations, and promotes sustainable water use.

Loughton Town Council's maintenance person has estimated a cost of £300 to produce the 13 covers.

Agenda Item 12 **Loughton Wombles**

Further Loughton Wombles group litter picks took place on:

22 November 2025: Two groups covered the area from the Lidl supermarket, up Goldings Hill, finishing at Baldwin's Hill. Also, the full stretch of Torrington Drive, the Debden station approach, and the footpath running alongside Casis Court.

6 December 2025: Group 1 focused on the Mannock Drive area, to Rookwood Avenue, Rookwood Gardens, finishing along the Brook. Meanwhile, Group 2 concentrated on Chigwell Lane, covering the stretch between Borders Lane and the railway bridge. Their efforts continued along Borders Lane, up to Lucton's Path, the vicinity of the New City College Wellness Centre, and Ladyfields Close.

17 January 2026: Group 1 group focused on the Pyrles Lane shopping area, Hillyfields Green, and the full length of Hillyfields. Meanwhile, Group 2 covered Chester Road, litter picking the stretch between Pyrles Lane and Davenant School in Willingale Road, including the communal grass areas along the route.

Dear parish/town clerk,

I am contacting you on behalf of the Transport Made Simple group, we operate Central Connect and Konectbuses bus services across Essex, if you are receiving this email it is because your parish/town council lies within a ward that is served by one of our bus routes, if you are already in touch with me about a bid please feel free to ignore this message.

Essex County Council is offering grants of up to £50k for parish councils in Essex to enhance or promote their bus services, as an operator we are keen to see as many of you apply as possible to help us improve our services and get more people on our buses, more details and guidance about this scheme can be found at the link at the end of this email. The deadline for applications is coming up soon on the 31st of January, as such I would be more than happy to support you in the process of writing up an application to ensure it can be submitted on time.

These funds can be used for any operational or marketing funding of services, unfortunately this does NOT include funding for capital expenditure such as new bus shelters. If you have any ideas or proposals for changes/enhancements to a service in your parish I would be able to look into it with our network team and create a bid if it is operationally feasible within the up to £50k available. I have also prepared some template bids for marketing such as leaflet drops, we have an in-house graphic design and marketing team with extensive experience focussing on promoting bus services who would be able to prepare and possibly distribute such materials minimising any work you would otherwise have to do finding a marketing agency, we would be happy to work with you to design a tailored and targeted promotional campaign for your local bus service through this grant. Similarly, the scheme can cover promotional fares such as discounts, loyalty incentive schemes, free travel for under 22s, etc, I have also prepared a number of template bids for this type of promotion.

If your parish/town council has any interest in seeing their local bus provision improved or promoted to get more people on board then please reach out to me by email and we can arrange a time to meet or call to work out details so I can prepare a bid for you to submit. I'm looking forward to working with you,

Recycling Briefing

“Next step in Recycling Food & Garden waste collections briefing”

- As of 31 March 2026, food and garden waste will be collected separately by different vehicles.
- Garden Waste Service – Residents will have to sign up on-line and pay £60 per year subscription fee and then they will receive a permit for fortnightly collections, residents will continue to use the current green lidded bin.
- Food Waste Collections – properties will receive a kitchen caddy and a kerbside caddy. Which will be collected weekly at no extra cost.
- This change will improve recycling and reduce costs and align with other councils in Essex. It will keep Council Tax fair and low and give residents choice. Residents should be encouraged to do the right thing, 25% of food waste is still in black bins and this ends up at the Energy for Waste site or landfill, but if it is recycled it can be made into fertiliser for farming.

Town Clerk (TC) to TT 18.12.25,

Comments made by our Town Councillors at our last meeting were as follows:-

Members agreed this in principle, but they were disappointed that there was no mention of a treasure trail for the Debden side of Loughton.

- *Thoughts were that the 'treasure trail' can be amended, such that it can start by going directly along Station Road, several items of interest including the course of the old railway between the first station, on the site of the Lopping Hall, and Sainsbury's roundabout, thus avoiding Alderton Hill and Brook Rd.*
- *On the return leg I think it should progress direct down and return to point two. I think this would shorten the route by about half a mile.*
- *The points made about the route not including Debden are understandable but to include Debden would make the walk far too long.*
- *Another short walk around Debden might start at Debden Station and take in St Nicholas Church, Loughton Hall and the E15 acting school with its Sussex barn and Hatfields house. It should then return along Rectory Lane to the Broadway and from the station could progress over the footpath footbridge to Langston Rd and the Bank of England works. One of our Town Councillors can draw a map and provide information if needed.*
- *For the old Loughton leg, the Loughton District Historical Society publication 'Walk round Loughton 1995' is still largely relevant.*

p.s. *The author Chris Pond is a local historian and very knowledgeable of Loughton history and geography. He is also a Loughton Town Councillor.*

Other ideas included visiting Loughton Conservation area (around York Hill), Loughton Leisure Centre, Lopping Hall and Loughton Cricket Club.

I don't think we will have any problem filling the itinerary.

Many thanks for sharing the Town Councillors' comments – we really appreciate the time taken to review the draft and to feedback local perspectives.

It may be helpful to briefly clarify scope and process, so we're all aligned as the project moves forward.

This Trail has been commissioned by Epping Forest District Council as a single, self-contained walking Trail for Loughton, designed to fit within a defined distance, duration and experience framework that works for a broad audience. Within that brief, our role is to create a coherent and engaging route, rather than attempting to represent every area or interest within one product.

With that in mind:

- *Debden*
The desire to see Debden represented is completely understandable, and we agree with the view expressed that incorporating it into this Trail would make the route too long and change the nature of the experience. Realistically, Debden would need to be developed as a separate Trail with its own start point and focus. That could certainly be considered as a future opportunity, but it sits outside the scope of the current commission.
- *Route refinements (Station Road, Alderton Hill, Brook Road, Smart's Lane, return leg)*
These are the kinds of refinements that are best assessed during the site visit, once items of interest, pedestrian flow and overall route balance can be properly evaluated. Our general approach is to avoid overly linear or repetitive sections where possible, and to include quieter or lesser-known areas when they add interest and character.

We're very happy to review these sections on site before finalising the route.

Additional points of interest

Many of the locations mentioned are already passed by, or naturally sit close to, the

proposed route. We'll ensure these are considered appropriately, but without forcing inclusions that don't meaningfully enhance the overall Trail experience.

Overall, while we genuinely welcome consultation and local insight, it's important that the Trail design remains focused and manageable. As discussed previously, too many parallel inputs at the design stage can make it difficult to deliver a clear, high-quality end product, so we're keen to maintain a clear and consistent design process.

Our next step remains the site visit, after which the route will be finalised in line with the agreed brief.

Myself and will be writing and putting the Loughton Trail together. We'd be more than happy to meet up for a coffee on the day to chat through things and look over a few details. As Aaron mentioned, when it comes to actually walking and writing the Trail, we'll need to be in a particular mindset and fairly focussed on the writing process during that stage.

We just need to get a few other things in place before we can confirm when the site visit will be, but I'll let you know as soon as we have a plan in place.

TT to TC & EFDC 16.1.26

I've now put together a few ideas for back stories relating to the Loughton Treasure Trail (please see attached). Waltham Abbey chose their back story at the end of last year and picked a Treasure Hunt theme, so I'm looking to do a Spy Mission and Detective Mystery for the other two Trails (Loughton and Ongar).

Please have a look through the rough ideas and see if there's one that takes your fancy, or if there's another area that you think we should be focusing upon. You'll see there are a couple of ideas that won't actually be passed on the Trail (such as Loughton Camp), so they might not be ideal but I think they could still work.

I've also attached a document outlining how the back stories work for each of the three themes that we do at Treasure Trails and their answer mechanisms.

TC to TT & EFDC 20.1.26

We have a Town Council committee meeting next week on Wednesday 28 January and I can put these concepts forward to our Town Councillors.

Will residents be charged for using this trail?

EFDC to TC & TT 20.1.26

Our package with Treasure Trails includes either 1,000 printed copies or 1,500 digital copies of the three trails we have commissioned.

Our current plan is to proceed with the digital option, which would give Loughton approximately 500 digital copies. We believe the most effective way to get these into the hands of residents is through schools (in time for the Easter break), although the specific schools and year groups are still to be confirmed.

In addition to this, the trails will also be available for the public to purchase directly from the Treasure Trails website at £9.99.

We also have the option to purchase the trails from Treasure Trails at cost price and stock them at locations such as the Waltham Abbey Museum or Epping Forest Visitor Centre, allowing those venues to generate some revenue themselves. I'm all ears for suitable locations in Loughton who may consider this opportunity.

Loughton Back Story Ideas (Detective Mystery & Spy Mission)

Loughton Camp & Dick Turpin

- **Detective Mystery:**
Fresh rumours suggest Dick Turpin may have been *less* dashing outlaw and *more* dodgy deposit-hider, with something valuable still linked to Loughton Camp. When a modern-day history buff goes missing from the paperwork trail, detectives must work out who's stirring up the legend — and who wants it quietly buried again.
- **Spy Mission:**
HQ believes the Turpin tales are being deliberately exaggerated to distract from something far less glamorous but far more important at Loughton Camp. Agents must separate myth from reality before folklore completely runs away with the facts.

Epping Forest

- **Detective Mystery:**
Boundary markers around the forest edge are turning up in the wrong places, sparking confusion, complaints and the odd raised eyebrow. Is this clumsiness, cheekiness, or a calculated attempt to move the forest one sneaky step at a time?
- **Spy Mission:**
Long ago, subtle forest features were used as reference points in quiet agreements. Agents are sent in to check whether those markers are still telling the truth — or if someone's been quietly nudging history off course.

York Hill Conservation Area

- **Detective Mystery:**
A review of historic buildings uncovers curious inconsistencies in dates, designs and old approvals. Someone appears to have been playing fast and loose with the past — and detectives must spot what doesn't quite add up.
- **Spy Mission:**
York Hill's architectural quirks were once used as low-key verification markers. When one no longer matches the records, agents must decide whether this is innocent restoration... or something a little more deliberate.

Lopping Hall

- **Detective Mystery:**
A document linked to a key moment in Loughton's development has gone walkabout. With plenty of suspects and no shortage of opinions, detectives must work out who borrowed it — and who never planned to give it back.
- **Spy Mission:**
Lopping Hall once hosted discreet meetings that were meant to stay discreet. Agents are tasked with confirming whether an old agreement was followed to the letter... or quietly "reinterpreted".

National Jazz Archive

- **Detective Mystery:**
A rare item in the archive appears to be incomplete, altered or oddly annotated. Was it a mistake, a prank, or someone trying to rewrite musical history with a creative flourish?
- **Spy Mission:**
HQ suspects certain markings within jazz memorabilia were once used as subtle authentication codes. When one item fails the test, agents must retrace the trail and find out what's been changed — and by whom.

The Great Lopping Dispute

- **Detective Mystery:**
New information threatens to reopen old arguments from the Great Lopping Dispute — an episode best described as "spirited". Detectives must identify who's dug it up again, and whether it's truth, misunderstanding, or mischief.
- **Spy Mission:**
A long-forgotten group set up to protect the outcome of the dispute may have quietly reactivated. Agents are sent to check whether they're still defending history — or bending it to suit themselves.

Shaftesbury Retreat

- **Detective Mystery:**
Records suggest something once left at the Retreat for safekeeping never quite made it where it was supposed to go. Detectives must untangle whether this was forgetfulness, foresight, or a very polite form of theft.
- **Spy Mission:**
The Retreat was once used to quietly protect sensitive material. Agents must follow understated clues to determine whether an item was hidden for the right reasons — or quietly redirected.

Every Treasure Trail we create begins with a fictional backstory that sets the scene for the entire Trail and establishes the narrative tone used throughout. These stories are usually inspired by the history, background or legends associated with the location itself. While rooted in real events or local facts, we then weave in gentle humour and imaginative embellishment to make the experience engaging and accessible for all ages.

As Trail-goers solve the clues along the route, each answer contributes towards unravelling the central mystery behind the Trail's theme. Depending on the format, participants may eliminate suspects and pieces of evidence to uncover whodunnit, cross off locations on a treasure map to reveal where the treasure was buried, or record answers in a Mission Answer Grid to crack The Solution Code and stop the enemy agents in their tracks.

Below are three example backstories, along with their corresponding answer pages, taken from a series of Trails recently commissioned by Rochford District Council in Essex.

Detective Mystery - Rochford Church, Town & Reservoir**Confidential Case Files****Ruffs, Riddles and Royal Rubies in Rochford!**

Rochford Hall has always shimmered with Tudor secrets – but one mystery is about to cause a proper crown-tastrophe! Rumour has it Anne Boleyn once hid a priceless gem, along with a scandalous letter that could've rocked the royal court (and popped a few pearls). But now, this letter has disappeared... and someone clearly wants the past to stay locked in the jewellery box. Enter Detective Chief Inspector Gemma Stone – a master of sparkle, subtlety, and sniffing out scandals! DCI Stone suspects foul play... and needs your help to unearth the truth. With clues scattered like rubies across Rochford, you'll need a keen eye and sharper wit to follow the glittering trail. But beware... some of the suspects are polished pros: the bragging historian, the slippery antique dealer, the shifty groundskeeper, and a tourist who's way too nosy. Can you crack this case, restore the sparkle, and stop a full-blown Tudor crown-flict?

This story is inspired by the history of Rochford Hall, formerly the home of Thomas Boleyn, father to Anne and Mary Boleyn. It also leans into the enduring rumour that Anne Boleyn and Henry VIII used hidden tunnels in the area to conduct their secret meetings.




