Agenda Item 8 Essex County Council New Unitary Authorisation consultation



We urge parish and town councils to hold an extraordinary meeting if necessary to agree on their response to the Consultation on New Unitary Authorities for Greater Essex. The Consultation is Now Live.

This is the biggest change to local government in Essex in over 50 years—please make your voice heard.

The Government announced a public consultation on all four proposals for new unitary councils in Greater Essex yesterday, 19th November, which will run until Sunday, 11 January 2026.

Details about how to take part are available on the LGR Hub: https://www.essexlgrhub.org/stronger-greater-essex. and Government is expected to decide on the final model for Greater Essex in the Spring of 2026.

Following yesterday's Ministerial announcement, the government has launched a consultation on proposals for Local Government Reorganisation (LGR) in Greater Essex. The consultation runs until 11 January, with a decision expected in Spring 2026

Four different proposals are being considered, ranging from three to five new unitary councils. Full details, summaries, and supporting documents are available on the Greater Essex LGR Hub, along with a toolkit and communication assets for partners.

Agenda Item 12 Reports from Members on Outside Organisations

1. Tree Wardens Meeting at Civic Offices held on 28.10.25

The meeting was attended by four tree/Countrycare officers and ten Tree Wardens.

Tom Simon of Countrycare chaired the meeting and reported on the new 50 Favourite Trees project which is being undertaken as one of the events to commemorate Countrycare's 40th birthday next year. Favourite trees can be nominated online with entries closing in May 2026.

I've submitted two trees for consideration. One is the Black Poplar tree by the Charlie Moulls Bridge on the Chigwell side of the River Roding and thus inside the Roding Valley Meadows Nature Reserve and was planted on the day the RVMNR was designated as such which will also be 40 years ago next year.

The other tree that I've selected is in Epping Forest and is said to possibly be the oldest tree in the Forest. It is visited on "My Favourite Walk in Epping Forest" and is featured on an information board at the Visitors' Centre at High Beach. It is a Beech "coppard". A tree that was originally coppiced, allowed to regenerate, and then pollard. I was surprised to learn at the TW meeting that some people have given this tree the name of the "castle tree".

TS continued to report on various issues including that there are 464 Oak trees on EFDC Housing land throughout the District and that OPM's (Oak Processionary Moth) are a big problem within the District. He concluded his report by saying that he would be attending the East Anglia Tree Warden Forum to be held at Cockfield in Suffolk on Saturday 1st November 2025.

There followed reports from Tree Officers and Tree Wardens and it was disappointing to hear that lack of funding is leading to street trees not being replaced after they have had to be removed.

II. Epping Forest District Association of Local Councils meeting at Thornwood Common Parish Hall held on 5.11.25

This meeting was attended by the Town Clerk and myself and I was asked to chair the meeting which I agreed to do.

The meeting was quite well attended, and we considered the new draft EFDALC Constitution which had received prior approval from five of the Local Councils. The draft Constitution restricted Councils to having two members at a meeting but with all councils restricted to one vote. The member representatives could both be officers or both be councillors or one officer and one councillor. I had no objections to these proposals but did request an amendment to allow, if necessary, a third representative from a council to attend but with observer status only. I felt this could be useful for a councillor or officer to gain experience of how the Association works in the event of a future substitution being required or to help with a continuity situation. I'm pleased to say that my suggestion was considered and approved.

EALC Executive Committee.

Beverley Rumsey (Clerk) and Cllr Shelia Jackman had retired from this Committee and it was agreed that they would be replaced by the Waltham Abbey Town Clerk, Miss Natalie Page and Cllr Jason Gunn who is the Chairman of Ongar Town Council.

The meeting continued with discussions on planning matters with Cllr Liz Burn being particularly knowledgeable on that subject and she also reported on future training sessions.

Local Government Reorganisation/Devolution was also discussed, and it was agreed that Adriana Jones and Cllr Liz Burn would continue to work together to update the Parish/Town Charter.
