Agenda item 4.1 Building Design Award

The current annual award scheme is intended to recognise and reward individual examples of good design and construction and to raise public awareness of the built environment within Loughton. Any member of Loughton Town Council may submit a nomination form to recognise significant contributions during the previous 12 months for building works that:

- enhance the town
- improve a dilapidated building
- upgrade or enhance a conservation area
- noteworthy in terms of design or innovation

The current Terms and Conditions are given below for reference.

- 1. Works or improvements carried out by, or for a member of Loughton Town Council and its employees, or their relatives, are not eligible for this award.
- 2. Nominations are to be submitted on the form provided by 31 January 2016.
- 3. A photograph should be included with the application.
- 4. Please do not inform the nominee you have put his/her name forward.
- 5. The applications will be checked by Loughton Town Council officers to confirm compliance with current planning legislation and building regulations.
- 6. The judging panel will comprise the Town Mayor, Chairman of the Planning & Licensing Committee and the Chairman of the Environment & Heritage Committee, whose decision will be final.
- 7. One single award to be decided, however, there is no compulsion to award in the absence of valid nominations.
- 8. The winner of the Award will be presented with a plaque at the Council's Annual Town Meeting.

This is a prestigious award and the Town Council may like to follow the example of other local authorities that have increased its significance within their communities by opening up the competition to the general public and also seeking nominations from developers, agents, owners and/or community organisations.

There can be awards for different categories, which may include for example a 'people's favourite' that only members of the public can vote on. The judging panel may also include independent experts.

Epping Town Council has a Civic Award scheme and invites local organisations to recommend a building that has been well designed or maintained during the year. The Planning Committee chooses the winners from the nominations received and the awards are presented at the Annual Town Meeting.
