## 6 Street Lighting

The Council is asked to endorse the Town Clerk's response to the District Council as follows:

Loughton Town Council is interested in this idea, but will need to consider the matter thoroughly. We may not be in a position to make a speedy decision given that our budget preparations for 2019/20 are almost complete.

We have some initial queries on the initiative. Could you confirm whether:

- 1. we could elect to have lights on for Friday and Saturday nights only (days on which the Night Tube runs) at 2/7ths of the cost; and
- 2. *if we could decide to start midway through the financial year on a pro-rata basis?*

Additionally, a request for more information has been submitted:

- 3. a detailed breakdown of the costs; and
- 4. whether the commitment of parish and town councils to this proposal will delay the installation of LED street lighting in this district.

The Council is asked to confirm its position on this matter.

## Street Lighting – copy of email text from Acting Chief Executive, EFDC

You may be aware that as a result of concerns raised by local residents. the District Police Commander, the Member of Parliament for Epping Forest, and the Leader of the District Council, have been working closely with Councillor Kevin Bentley, Cabinet Member for Infrastructure at Essex County Council, about the possibility of reinstating all night street lighting.

As a result, Councillor Whitbread was able to advise the December Meeting of Full Council, that he was now in receipt of the estimated costs of all night illumination at Town and Parish Council level. Councillor Whitbread also informed Members of the District Council that he hoped that Town and Parish Councils who wished to see the reinstatement of all night lighting in their local areas, would give serious consideration to funding the initiative.

To this end, please see below the list of Town/Parish areas and estimated costs provided by Essex for your consideration. You will see that the County Council have only identified 14 out of our 24 Town/Parishes. I have asked for clarification on this point, however, it may be that some local Councils e.g. Theydon Bois or indeed some of the small rural parishes do not have street lighting infrastructure provided by the County Council. However, you may well have local knowledge which would clarify the omission.

Notwithstanding, if you would like to be part of the all night lighting initiative, could you please formally confirm both your interest and willingness to meet the costs. Our understanding is that the costs are in relation to electricity only, and no other maintenance charges will be made. I fully appreciate that this proposal has come at a time when your budget planning is well advanced. However, some Town/Parish Councils have already indicated that they may in the first instance use reserves, as opposed to precepting for the cost.

The Leader of Council is due to meet with Councillor Bentley in the next two weeks to feedback on the potential level of interest. Therefore I would appreciate a response, if only in principal, as soon as practically possible. Unfortunately, I am not in a position to provide any further detail around which individual lights are Essex responsibility, based on the level of information provided by Essex to date. Similarly, I believe there is little flexibility to partially light some areas and not others. It would appear to be all night street lighting or the current partial lighting arrangement.

## Agenda item 7 – Council Precept for 2019/20

The Council is asked to consider:

- i) the budget for 2019/20;
- ii) the amount to be taken from reserves; and
- iii) the level of the precept.
- 7.1 At its meeting on 9 January 2019, the Resources and General Services Committee considered the Estimates submitted by all the committees. It also looked at the Council's running costs for 2019/20 and the forecast General Reserves at the end of 2018/19. The budget savings proposed in the agenda report were accepted with the exception of that for the Roding Valley Recreation Ground play area where £10,000 new money towards the refurbishment project remained.

## 7.2 Use of Reserves

The budgeted net core running costs for 2019/20 amount to £411,593. (*This derives from the sum of column 1 of each of the revised committees' rolling programmes less their estimated income.*)

The forecast for the level of general reserves as at 31 March 2019 is £281,870.

Using £25,000 from the forecast general reserves reduces them to £242,458 equivalent to 62.41% of the budgeted net core running costs. This meets the Council's reserves policy.

## 7.4 Precept for 2019/20

For information: The tax base for 2019/20 has been confirmed as 12,580.6. (*This is the figure that when divided into the Precept gives the Band D figure.*)

## **RECOMMENDED** that the Council's precept for 2019/20 be set at £719.000.

This will give the Loughton proportion of the annual council tax for a band D property as £57.15, an increase of £3.56 on that for the current year of £53.59.
