

The first of the three columns for each financial year provides details of the cost of running the core services; for PLC this is only the service recharge which is shown underneath – the cost of running the committee. The second column shows expenditure items already agreed in principle by the Committee that provide enhanced services. The final column provides additional items to be confirmed or amended by the Committee. This particular layout provides data to assist with the precept process and helps ensure that the level of general reserves held continues to meet the Council's reserves policy. Forecasting where appropriate has been included to allow forward planning.

It is not clear at this stage when the public enquiry for the Local Plan is to be held and so it has been assumed that this will be in the new financial year. Should this occur earlier, the related expenditure can be met from earmarked reserves.
