Council Precept for 2017/18

5.1 At its meeting on 11 January 2017, the Resources and General Services Committee considered the Estimates for income and expenditure submitted by all the committees. It also looked at the Council's running costs for 2017/18 and the forecast General Reserves at the end of 2016/17.

Budget savings were considered across the committees and, as requested by the Committee, the Chairman and Vice Chairman considered the implications and identified priority items of new expenditure.

It is **RECOMMENDED** that the budget for playgrounds held by the Recreation Committee be increased to include an additional £3,297.

The Committee's recommendation for the precept for 2017/18 is shown below. Full budget details may be found in Appendix A, provided under separate cover.

The final net expenditure figure of £297,200 also shown on page 11 of Appendix A will be reduced to zero by the proposed use of reserves as follows:

5.3 Use of Reserves

The budgeted net core running costs for 2017/18 amount to £377,953. (This derives from the sum of column 1 of each of the committees' rolling programmes less their estimated income)

The forecast for the level of general reserves as at 31 March 2017 is £309,352.

Using £72,000 from the forecast general reserves reduces them to \pounds 237,352 equivalent to 62.8% of the budgeted net core running costs. This meets the Council's reserves policy.

5.4 Precept for 2017/18

For information: The tax base for 2017/18 has been confirmed as 12,294.8. (This is the figure that when divided into the Precept gives the Band D figure.)

RECOMMENDED that the Council's precept for 2017/18 be set at £634,800.

This will give the Loughton proportion of the annual council tax for a band D property as \pounds 51.63, an increase of \pounds 2.45 on that for the current year of \pounds 49.18 which has stood at that level for 7 years.
