PROPOSED BASE STATION UPGRADE AT CTIL_206347 23, TEF_67646, EPPING NEW ROAD, WARREN HILL, LOUGHTON, ESSEX, IG10 4AA (NGR: 540961, 195491)

CTIL and Telefónica identified this site as suitable for an equipment upgrade. The purpose of this letter is to consult with you and seek your views on our proposal before proceeding with the works. We understand that you are not always able to provide site specific comments, however, CTIL and Telefónica are committed to consultation with communities for mobile telecommunications proposals and as such would encourage you to respond.

As part of Telefónica's continued network improvement program, there is a specific requirement for an upgrade at this location to provide improved 2G, 3G and 4G network coverage for Telefonica in the area.

Mobiles can only work with a network of base stations in place where people want to use their mobile phones or other wireless devices. Without base stations, the mobile phones and other devices we rely on simply won't work.

Please find below the details of the proposed site: -

Our technical network requirement is as follows:

- CTIL_206347 23, TEF_67646, Epping New Road
- The proposed upgrade will provide improved 2G, 3G and 4G network coverage for Telefonica in the area.

We consider the best solution is as follows:-

- Epping New Road, Warren Hill, Loughton, Essex, IG10 4AA (NGR: 540961, 195491)
- The proposed development comprises the replacement equipment within the existing equipment room and development ancillary thereto.
- This option has been chosen to utilise the existing installation to improve coverage with minimal changes to the existing equipment, minimising the visual impact on the surrounding area as far as technically possible.
